TOP 1 Protocol Nr. 85/3 of the meeting of the Board in Amsterdam on November 15, 1985

This protocol is adopted unanimously

TOP 2 12th International Congress in Wien, August 26 - 29, 1987

In the morning of July 1, 1986, the Board visited the congress site of the 12th International Congress, the Wirtschaftsuniversität, Augasse, A-1090 Wien. In the Wirtschaftsuniversität, 3 types of auditoria are available: the auditorium maximum with 634 places, 4 medium sized auditoria with 174 places and 2 small auditoria with 92 places. In the aula, there is enough room for the industrial exhibition which will take place during the congress. There is a possibility for simultaneous translation in the auditorium maximum which will be used for the general assembly of the Society. The Board accepted the Wirtschaftsuniversität Wien as site for the 12th International Congress.

Up to now, 102 preliminary registrations have been sent to Interconvention, the company which is taking care of the administrative part of the congress.

The following congress fees have been fixed: members, early registration (before April 30,1987) öS 1400,-members, late registration öS 1700,-non-members, early registration öS 1700,-non-members, late registration öS 2000,-technicians, early registration öS 500,-technicians, late registration öS 800,-accompanying persons, early registration öS 800,-accompanying persons, late registration öS 1100,--.
For the "Heurigenabend", the fee amounts to öS 150,-A new budget for the congress based on these figures and taking into account a wellcome party (August 25, 1987) as well as the costs for the invited speakers will be elaborated by Interconvention.

An outline of the program for the congress has been fixed (see Annex 1). These general ideas will be incorporated in the preliminary program which will be mailed in November 1986. The deadline for the receipt of abstracts is February 28, 1987.

The Proceedings of the congress will be published by the Springer-Verlag; B. Brinkmann will arrange the contact between Springer and W. Mayr. The articles should not exceed 10 pages (invited speakers) or 5 pages (oral presentations or posters); the number of figures will be restricted.

TOP 3 Criteria for the scientific award

The papers should be of "outstanding" quality. For the next general assembly, the statutes for the award should be revised in order to insist on this aspect; furthermore, the submission of papers for the award should be open to non-members of the Society. P. Lincoln will prepare a draft taking into account these points.

The situation concerning DNA polymorphisms is extensively discussed. The Board will publish a resolution pointing out that the definition of RFLPs should not be the monopoly of a single laboratory and that the probes should be made available to all workers which are interested in this topic. This resolution should also take into account the AABB quidelines (which will be circulated by P. Lincoln) and the fact that the formal genetics of several RFLPs have to be checked in further investigations. B. Brinkmann will produce a draft of this resolution after the seminar of the English speaking working group in The Hague on October 24, 1986.
