6a) Scientific Prize

6b) EDNAP, ENFSI; DNA Commission

B. Olaisen received a letter by D.J. Werrett stating that the ENFSI would like to become a Working Party of the ISFH. Furthermore, B. Olaisen was asked to help the EDNAP to solve some questions (e.g. admission of new representatives from countries already represented in the EDNAP and also from countries not represented in the EDNAP). After a long discussion, the Board decided that a meeting should be organised in August 1998 in Santiago de Compostela in which some members of the Board (with B. Budowle and possibly B. Brinkmann [who spend his holidays near to Santiago de Compostela]) and competent representatives of the EDNAP and of the ENFSI should discuss the function of these 2 organisations; the fields of activity of EDNAP and ENFSI should be defined clearly in order to avoid major overlappings between both groups. In any case, the admission of the ENFSI as Working Party must be discussed during the next General Assembly. Concerning the DNA Commission of the ISFH, the Board states that this commission should give opinions on general topics but should not go too much into details of the daily routine.

6c) International Congress 2001

C. Doutremepuich (Bordeaux/France) informed B. Olaisen that he would like to organise the Congress 2001 of the ISFH in Arcachon (approximately 40 km west of Bordeaux). The Board gratefully takes note of this offer and will inform C. Doutremepuich that he should invite the ISFH in the next General Assembly to convene in Arcachon.
