STATUTES FOR THE BIENNIAL SCIENTIFIC PRIZE OF THE ISFG

§1 Designation

The prize is awarded for outstanding scientific work in the field of Forensic Genetics. Division and corresponding distribution of the prize among the members of a team is possible.

§2 Application

Candidates can either submit their own application or can be nominated by a member of the Society. Applicants will be invited to submit their application for the prize by a notice published in a newsletter of the Society. Applicants must submit a paper or papers covering all details of their methods and findings. Published or unpublished papers may be submitted.

It is expected that a paper on the relevant work will be presented by the winner or winning team as appropriate, at the International Congress of the Society.

§3 Examination of the presented publications

Examination of the presented work falls within the competence of the Board of the Society. The Board is authorised to call in specialists for oral or written opinions when required. After an appropriate evaluation, the prize-winner will be selected and the bestowal will take place at the next International Congress of the Society.

§4 Constituents and amount of the prize

The prize consists of a diploma and a cheque for a sum normally between DM 5000,-- and DM 10000,--, the amount of which is determined by the Board.

§5 Financial basis

The prizes are taken from a fund which is currently maintained by interest from the Society's assets.
