The manuscript of the 2nd exercise on mRNA was recently submitted to FSI: Genetics.

mRNA exercise no 3: Cordula Haas and Jack Ballantyne have done some preliminary investigations of mRNA markers for saliva and semen. The goal is to have three mRNA markers for each tissue. The plan is to circulate reagents and samples in the autumn 2010. Results must be submitted by 1 March 2011 to be ready for the EDNAP meeting 6 April 2011. Ten laboratories expressed interest in participation.
